QUESTIONS AND ANSWERS

IFB # 090524MT – HVAC Replacements - Gordon Alternative, Raleigh Egypt MS, & Egypt ES

1. If asbestos, lead, or any other special or hazardous materials are encountered is MSCS's responsible for removal/abatement?

Yes.

2. Is professional liability insurance and pollution liability insurance required?

No, this is not required for this project.

3. The bid envelope does not show the A/E as needing to be listed as before. This does not appear to be a licensing law requirement with the State of TN (see below). Is the current bid envelope going to be sufficient since A/E's are not listed as required to be shown on bid envelope?

Bidding Law - TCA 62-6-119

- (1) The name, license number, expiration date thereof, and license classification of the contractor applying to bid for the prime contract;
 - (2) The name, license number, expiration date thereof, and license classification of the contractor applying to bid for the **masonry** contract where the total cost of the materials and labor for the masonry portion of the construction project exceeds one hundred thousand dollars (\$100,000);
 - **(3)** The name, license number, expiration date thereof, and license classification of the contractor applying to bid for the **electrical**, **plumbing**, **HVAC** and **roofing** contracts except when such contractor's portion of the construction project is less than twenty-five thousand dollars (\$25,000);
 - (4) For each vertical closed loop **geothermal heating and cooling project**, the company name, department of environment and conservation license number, classification (G, L or G,L) and the expiration date, except when the geothermal portion of the construction project is in an amount less than twenty-five thousand dollars (\$25,000);
 - **(5) Prime** contractor bidders who are to perform the masonry portion of the construction project which exceeds one hundred thousand dollars (\$100,000), materials and labor, the electrical, plumbing, heating, ventilation or air conditioning or the geothermal heating and cooling must be so designated; and
 - (6) Only one (1) contractor in each of the classifications listed above shall be written on the bid envelope or provided within the electronic bid document.

- 4. Does MSCS's verify contractor license limitations and local preference purchasing prior to award of contracts?
 - Yes, we verify licenses, however, local preference is not considered on ESSER projects.
- 5. Scope of Work states to use current MSCS approved chemical treatment vendor. Please provide contact information for current MSCS vendor.

- 6. Commissioning Requirements in Design Guide is blank. Please provide.
 - Rebalance all the hydronic system and on the air side rebalance any new equipment that is being replaced.
- 7. Are exhaust fans being replaced at schools?
 - **Bathroom Exhaust Raleigh Egypt ES**
- 8. There is a hot water unit heater in the boiler room at Gordon Alternative. Is this to be replaced? Is it to be hot water or electric?
 - Replace with new.
- 9. The SOW does not mention replacing hydronic specialties (air separator, expansion tanks, etc.). Please confirm these items are to be replaced.
 - Yes, if boiler or pump is being replaced related to it.

10. Is the kitchen hood, makeup air unit and kitchen exhaust a part of the Egypt ES bid?

No.

11. Are the cabinet heaters to be replaced at Egypt ES?

Yes.

12. There appears to be some rooftop units at Egypt ES that are not very old. Please confirm if these are to stay or be replaced.

5 years or older replace.

13. Are new duct smoke detectors to be installed at Egypt ES?

Yes, please use current MSCS Fire Alram Vendor

14. We have heard that the State is taking up to 6 months on some of their plan reviews. Obviously, the contractors cannot release equipment until plans are approved which could cause delays. What is the contingency by MSCS's if this timeline does not allow for completion by the scheduled completion date due to items that are beyond our control? We understand that there are time constraints in which MSCS's had to spend the ESSER funds, but this could cause delays in these expenditures.

The deadline cannot be changed on any ESSER project. The project completion dates are of utmost importance, and vendors will be held to their deadlines. Lead times and fire marshal review times should be included in the bid response. Liquidated damages should not be an issue, if timelines are fully planned out in the bid response.

15. Can MSCS's provide contractors with any available AS-BUILD drawings they may have?

16. Are domestic water heaters included in the SOW for all schools? (Domestic water – referring to potable drinking water)? If only some schools are to have them replaced, please confirm which schools.

17. Can you provide contractors with the TCAT testing dates and confirm no work will be permitted during those times? Will the contract be extended to compensate for time that is taken away?

MSCS does not have TCAT testing that I am aware of. Please visit MSCS website for test calendar

18. Design guide states that the contractor is responsible for cleaning and waxing of floors by a MSCS approved custodial vendor in the months of July and August prior to start of Teacher's term. Is this only for the areas where work is being performed? Will MSCS's reconsider this requirement? If we are complete with work in areas during the July/August timeframe, will MSCS's be responsible for the areas where work is complete? This just is a blanket statement that you are requiring HVAC contractors to clean and wax floors in the entire school during the July/August timeframe. If this won't be reconsidered, please provide a list of approved vendors so that we can contact for pricing to be included in our proposals. This seems like the district is doubling their costs of cleaning/waxing floors.
