IFB 090424LP HVAC Replacements Cromwell ES, Shrine School, Norris Achievement Academy

- 1. If asbestos, lead, or any other special or hazardous materials are encountered is MSCS's responsible for removal/abatement?
 - Yes
- 2. Is professional liability insurance and pollution liability insurance required? **Yes**
- 3. The bid envelope does not show the A/E as needing to be listed as before. This does not appear to be a licensing law requirement with State of TN (see below). Is the current bid envelope going to be sufficient since A/E's are not listed as required to be shown on bid envelope?

- 4. Please verify the completion date in this bid package is correct. All other bid packages have a completion date of 12/10/25.

- 5. Since each school is being considered separately, we are assuming a bid envelope for each project should be used along with separate bid bonds. Please confirm.

- 6. Does MSCS's verify contractor license limitations and local preference purchasing prior to award of contracts?

9. Are exhaust fans being replaced at the schools? If only some schools are to have them replaced, please confirm which schools.

- 10. Can MSCS's provide contractors with any available AS-BUILD drawings they may have? Please see the Design Construction Guidelines posted with the RFP documents on the SCS website, as an Attachment.
- 11. Cromwell ES Are cabinet heaters to be a part of the scope of work to be replaced?
- 12. Cromwell ES Are the Air Handling Units to be replaced? They are not called out on the Scope of Work.

- 14. Shrine School Are the FCU, UV's, AHU's being replaced at Shrine School or is it limited to just the chiller and boiler along with associated pumps?
 Follow the scope of work.
- 15. SOW states to replace controls in the entire Shrine facility and there is an add alternate that says to upgrade controls for entire building. Please provide further clarification on MSCS's intent. Sheffield shares this building with Shrine, is it to be included?

 Please follow scope of work. Base bid states mechanical plant and the alternate states entire school.
- 16. Are domestic water heaters to be included in the SOW for all schools? (Domestic water referring to potable drinking water)? If only some schools are to have them replaced, please confirm which schools.

Follow the scope of work.

17. Can you provide contractors with the TCAT testing dates and confirm no work will be permitted during those times? Will the contract be extended to compensate for time that is taken away?

Project completion dates are of utmost importance, and vendors will be held to their deadlines. Lead times and fire marshal review times should be included in the bid response. Liquidated damages should not be an issue, if timelines are fully planned out in the bid response.

18. Design guide states that the contractor is responsible for cleaning and waxing of floors by a MSCS approved custodial vendor in the months of July and August prior to start of Teacher's term. Is this only for the areas where work is being performed? Will MSCS's reconsider this requirement? If we are complete with work in areas during the July/August timeframe, will MSCS's be responsible for the areas where work is complete? This just seems to be a blanket statement that you are requiring HVAC contractors to clean and wax floors in the entire school during the July/August timeframe. If this won't be reconsidered, please provide list of approved vendors so that we can contact for pricing to be included in our proposals. This seems like the district is doubling their costs of cleaning/waxing of floors.

d) There is a BAS panel including the controls for RTU's for the original bldg. and a BAS panel including the controls for the addition. Does both of the existing bldg. controllers get upgraded to BACnet open protocol per the Design Planning Principles and Construction Guidelines dated Aug 12, 2024 and integrated into the bldg. edge/cloud device and GUI?

Please confirm which pump(s) do you want replaced. Replace all chill water system/loop and chill water primary pumps.
- 28. Shrine School: In the mechanical room you have three gas burning appliances. They are...
 - a) 1 Cleaver Brooks BOILER
 - b) 2 Parker indirect POOL HEATER
 - c) 3-2007 water heater SUF100150NE

Please confirm which pieces of equipment you want replaced – for by definition – there is only one (1) boiler.

Please follow scope of work.

- a) If the intent is to replace the old Pool heater with a new pool heater since there is not any guidelines or specifications in guidelines for a pool heater.
 Please reference the HVAC project scope of work calling for boiler replacement.
- b) Please confirm what type of pool heater do you want do you want a 85% eff pool heater or a high eff 95% eff pool heater or contractors choice? *Please reference the HVAC project scope of work calling for boiler replacement.*
- 29. The scope calls for "New pumps with VFDs/ Motor Starters"
 - a) Please confirm what pumps get starters and what pumps get VFDs. (IE do you want main dual temp pumps to get VFDs and smaller boiler pumps to get starters).

MSCS prefers new motor starters.

- b) Please clarify that this scope does not include the pool pump. *Please reference the HVAC scope of work.*
- 30. Norris
 - a) Is it your intent to rebalance the entire chill water, hot water, and exhaust system?
